## **Informative statement as set forth by art. 13 of L.D. 196/2003 (Privacy Code).**

1. According to art. 13 of L.D. 196/2003, we inform the subject that the personal data supplied for the payment of the 'Unpaid Toll Ticket', and the data supplied to issue the invoice for the payment are collected and can be used and treated - on paper and electronically - by people in charge of the treatment, and only for the purposes related to the management of the payment by the following highway licensee companies, each for the sections of its competence, in quality of independent Subjects in charge of treatment:

2. Granted what foreseen in previous point 2, the personal data collected and stored in the databases of the highway licensees in charge of treatment, will not be object of diffusion and, communication, other than the cases foreseen by law and with the methods allowed by law.

3. The data must be conferred to attain the above mentioned purposes; the lack, partial or incorrect conferment could lead to the impossibility to proceed with the payment online of the 'Unpaid toll ticket'.

4. The administrative activities relative to the online payment service and, in particular, to the elaboration of the receipt for the payment issued and elaboration and transmission of the invoices possibly requested, are carried out on behalf of the highway licensee companies indicated in point 1 by.

5. The subject concerned can contact the licensees indicated in point 1 to exercise his rights according to art. 7 of L.D. 196/03 (notify the update, rectification of the data, ask the treatment purposes and methods, know the details of the Subject in charge of treatment and manager, etc., and ask for the deletion of the data dealt in violation of laws). The personal data given by the subject concerned, will be stored for the time needed for the administrative definition of the payment, in compliance with applicable laws.
